## **Minister's Report**

#### Vision of the New Jerusalem

"Then I saw a new heaven and a new earth; for the first heaven and the first earth had passed away, and the sea was no more. And I saw the holy city, the new Jerusalem, coming down out of heaven from God.... The home of God is among mortals. He will dwell with them; they will be his peoples, ... [The] People will bring into it the glory and the honor of the nations." (Revelation 21:1-2b, 3, 26)

Above is a quote from John's description of a vision of the promised Kingdom – the New Jerusalem. It's an ecstatic, divine vision that John is shown in Revelation of what God wants for the redeemed Church and creation. This vision of the Kingdom – a vision that promises a place and time where all things, peoples, our hopes are united as one in Christ – has been the goal and aspiration of the Christian Church since it began: it is the aspiration of every community of faith as it seeks to represent Christ – to be Christ's Body – wherever and whenever it meets.

Standing behind the Communion Table at the end of the 175<sup>th</sup> Anniversary service on Sunday, October 16<sup>th</sup> was a "Kingdom" moment for St. Andrew's and me: there, in one service, was St. Andrew's as one body – the Body of Christ – worshipping in music, two languages, multiple cultures; in celebration; in hope and faith! It was, in that moment, not only a glimpse of John's vision of the Kingdom – the New Jerusalem, but also a vision of how far St. Andrew's has come!

2022 started off very much that same way 2021 ended – still under the cloud of COVID and the uncertainty of how to adapt pre-COVID activities and practices to the "new reality." St. Andrew's managed to faithfully navigate the pandemic through 2020 and 2021, but the 'fatigue' of dealing with the COVID rollercoaster took its toll on my health, and I ended up needing to take a 3-month medical leave. I am grateful to Rev. Wayne J. Baswick who stepped in as "Interim Minster" to cover the worship services and to moderate the Session meeting. I am also thankful to Jean Bradshaw who, as Clerk of Session, took on extra duties while I was on leave.

Unfortunately, 2022 also experienced the largest stock market correction in over a decade – creating a 'perfect storm' for St. Andrew's finances. While St. Andrew's is in a much better financial position than it was 10 years ago, all its eggs are in one basket! With the freezing of the PCC Consolidated Fund, where St. Andrew's Memorial Funds are invested, about a third of our annual income was cut off. Add to this the fact that we were unable to withdraw any of the funds from that Fund – meaning that that source of revenue was also unavailable. While its 2020-2021 COVID offering revenue was strong, St. Andrew's rental income was nonexistent due to the building being closed. For the first time in several years, St. Andrew's was faced with a deficit, bringing back fears that added to the uncertainty created by COVID. But there is so much more to St. Andrew's than this!

At the beginning of the pandemic, I believed that St. Andrew's not only had a future, but that it would be stronger and more diverse as it emerged from the adversity it was going through: and it is. St. Andrew's weathered the Summer and began the Fall with the hope that God would guide and bless it as it moved forward faithfully – as evidenced by the invitation to the 147<sup>th</sup> Moderator of the Presbyterian Church in Canada, The Rev. Dr. Robert Farris to preach at the 175<sup>th</sup> Anniversary service! And, what a service! About 150 people from both our morning and afternoon services attended, the choir sand special music and the Leap of Faith band played – as did the S-EAOM Music Team and Choir. And after the service, we held our first reception in the Great Hall in two and a half years where we served cake and enjoyed a long-overdue time of Fellowship!

From that Sunday, St. Andrew's has been regaining ground lost due to COVID. In-person worship attendance is increasing, our online attendance continues to be steady, the Session approved the reopening of the building to our renters, its Committees continued their work, and, in early 2023, returned to in-person meeting – with a hybrid online option. The year ended with another great response to our biannual Elder election that resulted in a great slate of new and returning Elders who have responded to the call to serve and lead St. Andrew's for the next 6 years. Advent and Christmas Eve brought with it a sense of a return to normalcy – and even a generational snowstorm didn't stop us from having our Christmas Eve and Day services!

As I write this, in March 2023, I have announced that, after over 10 years as the Lead Minister at St. Andrew's, I have received a Call to another congregation. It was not an easy decision to make, nor was it one I expected, but just as God called me to St. Andrew's out of the blue, God has called me to go. I



have been honoured to serve and lead St. Andrew's over the past decade. Much has been done – the development of the GRACE Groups; the restructuring of the Food Bank; the switch to a Term Service model for the Session; the establishment of a new, internally controlled Memorial Fund; the creation of the South-East Asian Outreach Ministry (S-EAOM) which has blessed St. Andrew's with its cultural diversity; the bi-annual Pre-Lent and Pre-Advent Events; and the annual Faith in ACT!ON campaigns – all to the glory of God and with the help of many people – past and present, and too many to thank here!

I knew when I came in 2012 that St. Andrew's was facing several challenges, but I believed strongly that God had a plan and a purpose for St. Andrew's, that it had a future and a role to play in making a difference in the community it is in – and because of this, we faced each of those challenges in faith and confidence. Standing behind the Communion Table at the end of the 175<sup>th</sup> Anniversary service, I knew that while St. Andrew's will have challenges ahead of it, God's plan and purpose for this congregation is still for it to be the best it can be – for it to be that vision of the Body of Christ, to be that community that reflects God's glory as an example of the "Kingdom" for all to see! I hope that you can see it, too.

In closing, I thank you for your prayers, support, friendship, and company as we journeyed together through the past 10 years. I will miss St. Andrew's, but I pray that God will bless and guide St. Andrew's, its Session, and Committees, and each of you – its members – as, together, you bring honour and glory to God in all that you say and do!

# Minutes of Congregational Budget Meeting November 20, 2022

### A Hybrid Meeting was held: 36 members in Sanctuary, 22 on Zoom

**Opening Prayer:** Rev. Geoffrey M. Ross opened the meeting in prayer.

Motion by H. Collins, Seconded by K. Shepherd: to appoint J. Bradshaw as recording secretary.

**AGREED** 

#### **Adoption of the Agenda:**

Motion by J. Bradshaw, Seconded by J. Young: to adopt the agenda as presented.

#### **Approval of Minutes of Previous Congregational Meeting:**

Motion by J. Bradshaw, Seconded by J. Collins: to approve the Minutes of April 3, 2022 Annual Meeting.

#### **Budget Presentation – Stewardship Committee Team and Committee Chairs:**

Stewardship Committee presented by H. Collins

A-M Dewar read the Vision Statement:

At St. Andrew's, we: learn together to know God's love through worship, study, and prayer; put our faith into action by loving and caring for each other; use God's gifts to go forth to bring others to Christ.

The Treasurer reminded the meeting that donations to the Food Bank, Presbyterian Sharing, and PWS&D are not included in the Budget.

H. Collins welcomed everyone to the meeting and thanked all the Committees for their hard work during 2022. She then asked each Committee Chair to explain what they hope to accomplish in 2023 as outlined in their budgets.

#### Mission & Outreach Committee presented by R. Kirkpatrick

Thanks to the congregation for their support and participation in its activities during 2022.

The Committee is busy making plans for 2023, hoping to expand its activities in the community.

The annual Faith in ACT!ON project will again be a main event. As the Santa Claus Parade has a new route, we will again hold a hats, mitts, scarves, and socks drive to donate to Ellen House and homeless people in downtown Brampton.

S-EAOM Team: The Budget is allocated to capital expenses to purchase envelopes, bulletins, instruments, curriculum, bibles, technology for online worship, Babar's salary, and an annual convention. We have applied for a Grant from Presbyterian Church in Canada; we will have to cut expenses if we do not receive it.

Women's Missionary Society (WMS) held many Zoom meetings throughout the year, but all fundraisers were canceled because of COVID.

#### Food Bank

The Food Bank at St. Andrew's does not have a Budget and receives most of its funds from the congregation. It also accepts donations of food and money from outside sources.

#### Christian Education Committee presented by K. Shepherd

The Sunday School lost five teachers during COVID, but this did not dampen the spirits of those remaining. We resumed Sunday School in October with a small group of children, and their enthusiasm is infectious. We will continue with the Pre-Lent and Pre-Advent Family events and hope to resume Vacation Bible School in 2023.

We are appealing for volunteers to teach; we have all the necessary materials.

We decreased our Budget for 2023 by \$700.00 as we plan to re-purpose the materials we have on hand.

#### Property Committee presented by P. Shepherd

This Committee continued to deal with the general maintenance of the building. Contractors take care of the lawn, snow removal, security checks., and the lighting on the outside of the building

The steps at the Church need repairing, and the Fire Panel must be replaced. These two items will be significant expenses.

#### Worship Committee presented by I. Jess

It is the privilege of the Worship Committee to provide support and guidance concerning Sunday morning Worship Services.

The number of worshippers in Church on Sunday mornings has increased now that the COVID restrictions no longer apply. We continue with online streaming on Facebook.

#### **Stewardship Committee**

#### The Proposed Budget for 2023 is presented by A-M Dewar, Treasurer

The Budget for 2023 is prepared on a cash basis and shows a deficit of \$83,000.00.

The offering is the largest source of revenue coming into the Church but is down by 50% in 2022.

The Fundraisers held in 2022 were North Country Meats, hanging baskets, and the sale of a book which brought in some additional revenue. 83% of the Stewardship Budget goes to salaries.

Other sources of revenue come from rent and weddings.

We applied for a P.C.C. grant to support the S-EAOM; their expenses will need to be reduced if we do not receive this grant.

- The Flame Endowment Fund is four years old, and funds are allocated as follows: The General Fund 40%; Programs, Mission, and Benevolent Fund 30%; Capital Facilities 30% or to a designated Fund.
- The value of the P.C.C. Pension Fund is down, and no income was received in 2022, nor are we likely to receive any payment in 2023.
- Enduring Gifts Fund is money left to the Church and a source of income. A downturn in the stock market means we did not receive revenue for 2022, nor will we receive revenue in 2023.
- The line of credit is zero, but we will use it in 2023, and the interest rate is 7.5%.
- We cannot afford this Budget, but with careful spending and increased offering, we should survive 2023.
- Anna-Marie reminded the congregation of the various ways to give: PAR (Pre-Authorized Remittance), e-transfer, and offering envelopes.

#### Motion by A-M Dewar, seconded by M. Harvey: to accept the 2023 Budget as presented.

**CARRIED** 

Thank you to Committee Chairs for their presentations.

Thank you to Anna-Marie Dewar, Treasurer, for her hard work preparing the Budget.

The meeting adjourned.

The St. Andrew's Session comprises 15 Serving Elders and the Ministerial staff. In 2022, we said goodbye to six Serving Elders: Kim Shepherd, Richard McMechan, Emanuel Emanuel, Colin Young, and Eunice Boyd. Paul Willoughby stepped down before his term of office ended. We thank all of you for your dedication and years of service on Session, and we look forward to working with you in the future as Supporting Elders.

The Session held an election for new Elders in December 2022, and the response was 73 ballots with 84 names submitted. The Session needs five Elders to serve six-year terms and two Elders to complete the terms of Elders who stepped down before their service ended.

The Session closed the Summer Session Team as their work since 2020 was no longer necessary. A great relief for six very tired Elders – thanks for your hard work and dedication!

The Session held two Leading With Care seminars in February 2022. Mr. D. Phillips from the P.C.C. led the seminars. 56 volunteers from our various Committees and Teams attended the workshops.

The various Committees were busy during 2022, holding fundraisers, running a successful Faith in ACT!ON campaign, and improving and maintaining the property. You can read the full details in the Committee Reports.

We welcomed back our renters; the Food Bank continues to serve a growing clientele weekly, and the I.T. experts continue to improve our digital footprint. We thank you for your continued patience, prayers, and support for all St. Andrew's ministries in the future. We ask for your prayers and support in 2023.

#### Working to Strengthen and Grow

Two GRACE Groups continued to meet via Zoom during 2022 but now meet in person.


The 2022 Pre-Lent Event was small but meaningful, but we had to cancel the Pre-Advent Event when the leaders were both ill.

How wonderful it is to be able to have in-person worship services once again, in addition to the services available online through Facebook. We are most grateful to the technology team of Peter Shepherd, Simpson Ross and Justin Kelly-Boxe who make this possible.

We continue to deliver copies of the newsletter to senior members of the congregation who are no longer physically able to attend church services, and do not have internet access. We have celebrated significant birthdays and anniversaries through articles and photographs in the newsletter.

During the year, cards were sent to members who were sick or had lost a loved one. As mentioned above, where we had the information on file we provided cards of celebration to those with special birthdays or wedding anniversaries. I sent a total of 47 cards in 2022, and I also received two cards from the members of the Congregation Care Team.

The Blue Christmas service in December was available online and in-person again this year. It is very comforting to those for whom Christmas is a difficult time of the year.

The Prayer Circle is part of Congregational Care, and Sandra Jackson has provided a separate report on this ministry.

Due to COVID restrictions, the Visiting Committee was inactive again this year, as seniors' residences and nursing homes were closed to visitors for most of the year. However, we made phone calls and delivered or mailed 13 Christmas cards – hand-painted and donated by Molly Harvey and signed by the Rev. Geoff Ross. In each card he included a personal message. These cards were much appreciated by the recipients.

With the church slowly returning to normal as more and more people felt comfortable returning to inperson services, we cannot forget those of our congregation who are worshipping online. Whichever way people worshipped, our many ministries and upkeep of the church were ongoing. We also thank you for generously supporting the designated St. Andrew's projects during our Easter, Anniversary and Christmas letter campaigns. Many of you used offering envelopes, e-transfer and PAR (Pre-Authorized Remittance); you may also donate through our website, <a href="www.standrewsbrampton.ca">www.standrewsbrampton.ca</a>, by clicking the 'Donate' button. For this method, Canada Helps processes your donations, forwards them to St. Andrew's, and issues a tax receipt directly to you.

#### **Food Bank Committee**

This has been a year of many changes for your foodbank. We started the year only allowing clients in one at a time and we served from the hallway and the kitchen with the clients gathering in the courtyard. We adhered to Session requirements and everyone who entered the building were masked, up to date on their vaccines and kept 6 feet apart. This worked because we were serving between 30 to 50 clients per week. The amount of clients climbed and we moved from the hallway to the food room and room 109 but still only allowed clients in one at a time and 6 feet apart. The cold weather came and we opened up seating in the Great Hall with space between the chairs but following all the other options for getting food. If clients weren't vaccinated we prepared a bag for them and gave it outside. We eliminated the requirement for vaccination but adhered to the spacing between clients as they collected food. The number of clients served has been steadily climbing and is now over 100 on occasions.

This year, rather than have a Christmas meal, the food bank volunteers decided to purchase backpacks and fill them with Christmas goodies as well as socks, scarves, toiletries, coffee cards and extra food.

The cost of food that we purchase has almost doubled but we have a generous Foodland store on Vodden where we purchase most of our supplies. The store has provided us with price discounts, additional food (sometimes skids worth) and stored price specials until we can use them. We also have had schools and other organizations do food drives as well as supporting us financially. This allows your food bank to purchase fresh food and offer a more balanced diet to the clients.

Over the year the client mix has changed. Many of the rooming houses have closed in downtown Brampton so we no longer serve those clients but the majority of clients are now on disability (ODSP) and Ontario works (OW) but the number of low-income families and recent immigrants that can't survive without food bank assistance is also rising.

Without your support and the many volunteers, your food bank would not be able to serve the disadvantaged in Brampton.

# **Prayer Circle**

St. Andrew's Prayer Circle Group offers prayers for those who are experiencing illness, loss, or going through difficult times. Prayer requests are received via the ministers, church office, personal emails, one-on-one conversations, phone calls, live Sunday Facebook service comments, or emails to: <a href="mailto:prayer@standrewsbrampton.ca">prayer@standrewsbrampton.ca</a>.

We respect everyone's privacy. The person, family member or friend we are praying for must be aware that the Prayer Circle Group is praying for them, and permission must be granted by the person we are praying for *before* their information is shared within the Prayer Circle Group ONLY. <u>All prayer requests</u>



are kept confidential unless the requester has asked the minister to announce it from the church pulpit, or they use comments via live Facebook Sunday services.

From January 1 to December 31, 2022, the Prayer Circle Group received **92 prayer requests** that resulted in **320 updates** from the initial prayer requests.

All prayer requests are tracked on a Word document shared electronically within the Prayer Circle Group members and issued monthly. This document is used to help us remember all who requested prayers. In addition, we pray for grieving families, our clergy, Session members, church committees, Grace groups, students at all education levels, South-East Asian Outreach Ministry, Canadian Military members, sponsored families, the end of racial prejudice based on colour or sexual orientation, and for truth + reconciliation of Indigenous Canadians. We also pray for those affected by COVID-19, church members with chronic health conditions, and those confined at home or in care facilities.

The administrator of this group is Sandra Jackson. Her vacation backup is Debbie Warwick, and the Reverend Rosemary Doran is the ministerial representative in the Prayer Circle Group.

# **Property Committee**

2022 was another busy year for the Property Committee. Keeping an old building in shape takes teamwork and dedication – something we have no shortage of. We have continued our weekly security walk-through and weekly property maintenance to maintain and secure the mostly-empty building.

The following is a partial listing of what has been accomplished in 2022:

**Renters:** New rental agreements were designed. We invited the remainder of our renting groups back. Unfortunately, some of them weren't able to get their membership back and have not returned. At the present time we have three groups renting space in the church on a regular basis – Seventh Day Adventists, DISMAS and an AA group.

**Church Security:** We have renewed our agreement with a security firm who checks the building nightly to ensure all doors are locked and secure.

**Boiler:** The boilers still need work which will be done this year.

**Organ:** The organ has had some minor repairs and was tuned. To quote our organist – "As a general rule, most of the organ is a hundred years old, so I highly doubt that all repairs will be 'finished'; it's more of a maintenance proposition."

**Annual Maintenance Contracts:** Contracts were re-signed with a lawn care company and a cleaning company for weekly grass cutting and weekly cleaning of the church building. The scope of work for cleaning was increased due to the increased activity in the building. We also re-signed a contract for snow plowing and shovelling of the walkways for the winter season.

**Kitchen:** Coming out of the pandemic, we discovered that our coffee machine didn't like sitting idle. We've determined it is not easily fixed. We will remove it from the kitchen and explore options. For the foreseeable future we'll use the smaller coffee urns. Our ovens have also come to the end of their life. A circuit board has failed and is not replaceable. We will remove the ovens for now and study the need and cost for replacing them.

Many thanks to Richard McMechan who is stepping down from the committee after a six-year term. Richard will stay on as a consultant to the committee for the Fire Panel project.

Thanks also go to Christian Shepherd who is stepping down for personal reasons. A final thanks to the remaining members of the Property Committee – Bill Dewar, Barry Ford, and Stan Loree who offer their time, talents and efforts to keep things running well.

My six years as a member of the committee have also come to an end. I've really enjoyed being involved. I have offered to remain available as things transition and until new members can be found. It's a great committee to be a part of. I encourage you to consider joining.

# **Worship Committee**

Throughout 2022, the Worship Committee worked to gradually and carefully support a busy year of fluctuation and transition. Many adjustments were made over the course of the year in light of changes to provincial COVID mandates and Session decisions.



With the introduction of the Omicron variant and a societal rise in infections, in-person worship was suspended for the month of January 2022.

February was a pivotal month for St. Andrew's. In-person worship resumed with all previous protocols in place: the Welcoming Committee monitored entry, seating and exit procedures; there was a 50-person capacity limit with pre-registration required to attend, along with check-in upon arrival, masking, socially-distanced seating, etc. Also in February, the Choir returned to regular practices, starting with Zoom practices. The Choir enjoyed presenting favourite anthems as well as new music, including "Home By Another Road", "Let Us Pray for Peace" and "Christ's Light is Shining" written by Shelagh Tyreman. With the return to in-person worship, and to encourage congregational participation, 2022 also saw the implementation of the "CP" (congregational percussion) program, whereby the Choir and congregational members are encouraged to join in on select hymns and service music by playing along on percussion instruments. Lastly, two Leading With Care virtual workshops were held in February for all Elders, committee members and staff.

With Rev. Ross away on medical leave throughout Easter, we were thankful to have Rev. Wayne Baswick lead us through the Easter season. In April, significant revisions were made to the COVID protocols: the S-EAOM congregation resumed their afternoon services, the Welcoming Team was disbanded, and pre-registration, distancing requirements and capacity limits were all dropped.

Spring and summer found the Worship Committee focussing on the plans for the 175<sup>th</sup> Anniversary Celebration Service to be held in the fall. Special thanks to Rev. Baswick for arranging for Dr. Robert Faris, Moderator of Assembly to be the guest speaker. We were pleased to welcome Rev. Ross back to the Worship Committee in September and have his input in planning the Anniversary. Special thanks also to all volunteers who stepped up to form a subcommittee to execute the plans for the Anniversary Celebration, and especially to Molly Harvey for authoring the commemorative booklet, *A Work of Faith, A Labour of Love*. The Anniversary Celebration was a joint service which included special music and participation by both the morning and S-EAOM congregations. By all accounts, the 175<sup>th</sup> Anniversary Celebration was a grand success.

In mid-September, the Senior Choir and Leap of Faith band transitioned from Zoom to in-person practices, and we enjoyed many musical highlights throughout the fall.

After a five-year wait, a sure highlight of 2022 was the arrival of the Bibi family, our sponsored refugee family. Sosan and her son Johnson arrived in June, while Sosan's son Jesse and his wife Sundril did not arrive until October, as they had to await the birth of their son Jesimile. We are delighted to welcome the Bibi family to worship with us at St. Andrew's!

In November, we greatly enjoyed having our trumpeter friend Lino Varano return to join us for our Remembrance Day service. Thanks to the leadership of Michelle Tedder, Coffee Fellowship was resumed at the end of November; volunteers are still needed to regularly continue this important time of friendship and fellowship.

The Christmas Season was well-celebrated at St. Andrew's with two services on Christmas Eve and the morning service on Christmas Day. As always, the music program provided exceptional enhancement to our services, with a highlight being the children's musical video. Special recognition must be given to the several individuals who stepped up in various capacities to fill in and ensure all Christmas Services were delivered when Rev. Ross was unavailable due to illness.

It was wonderful to welcome both returning and new members to the Senior Choir throughout 2022. The Choir held their traditional Epiphany Party through Zoom, playing several games to get to know each other better, including "Who Am I?", "Truth or Lie", "Show and Tell", and a Scavenger Hunt. The Grand Prize Winner of the evening was Pam Loree, whose prize was to wear a crown and conduct the anthem at the next Choir practice. Choir members learned more surprising things about each other than you could ever imagine! It was a great evening.

Worship Committee member Samina Babar, Clerk of Session Jean Bradshaw, and Music Director Shelagh Tyreman did some brainstorming, resulting in transitioning the Junior Music Makers program to include ALL the young people of St. Andrew's, both morning and afternoon services and our wonderful Sunday School members. The Young People of St. Andrew's were thrilled their video projects were part of the Easter and Christmas services and have been told they both were highlights.

2022 was a year of change and growth for the music ministry, but those who participate always feel blessed to be part of the community of St. Andrew's Church, and the congregation is privileged to enjoy their talents, led by our exceptionally talented Music Director, Shelagh Tyreman.

We would like to take this opportunity to welcome new Committee members Susan Jess and Michelle Tedder and to thank former members Paul Willoughby and Ian Jess for their service. Anyone interested in serving on the Worship Committee would be most welcome to join us.

The Worship Committee looks forward to continuing to serve St. Andrew's as we move forward into 2023.
