# **SESSION NEWS**

The April Session meeting was Rev. Geoff Ross' last meeting at St. Andrew's. Easter Sunday will be his last worship service, then he will be starting at his new Charge on May 1. He addressed the question of pulpit supply, pastoral care, and then asked St. Andrew's Presbytery Representative, Rosalind Cammidge, to give the Presbytery report. During her report, she informed the Session that Presbytery has appointed Rev. Wayne J. Baswick as Interim Moderator and Stated Supply half-time, effective May 1, 2023. Until then, he is the Interim Moderator at North Bramalea Presbytery Church.

## Annual Meeting Update

Due to Rev. Ross' Presbytery appointed leave – and the fact that Rev. Wayne J. Baswick will not start at St. Andrew's as the Interim Moderator – Rev. Ross outlined how the Annual Meeting scheduled for Sunday, April 23, can still take place. A motion was then made to nominate Stan Loree – an Elder and Trustee – to Chair the Annual Meeting. The motion passed. Stan Loree's name will be presented at the Meeting.
